Re: Raw Sugar TRQ Shortfall Reallocation

Dear Under Secretaries McKinney and Northey:

We are writing on behalf of our members who are sugar industries in quota holding countries under the U.S. tariff rate quota (TRQ) on raw sugar¹ in response to USDA's November 15, 2019 notice concerning the need for additional sugar supplies for the U.S. market.

We urge USDA to implement immediately TRQ shortfall reallocation under the 2019-20 TRQ. The earlier TRQ shortfall reallocation is announced, the larger the volume of imports in response. An immediate announcement of TRQ shortfall reallocation, therefore, would probably attract as much as approximately 100,000 MT of additional supply.²

In the event greater imports are required than would result from TRQ shortfall reallocation, we urge USDA to increase the raw TRQ. The Farm Bill requires USDA to increase the raw TRQ before increasing the refined TRQ, which can only be increased if domestic refining capacity has been "maximized." See 7 U.S.C. 1359kk(b). Many of ISTC's members have additional supplies of sugar available if the TRQ is increased. Again, the earlier in the year that the TRQ is increased, the more likely the quota holders are to be able to deliver.


We appreciate your consideration of our views on means to supply additional sugar for the U.S. market, including TRQ shortfall reallocation and a TRQ increase, both of which are of great importance to the members of ISTC and the other quota holders under the U.S. TRQ on raw sugar.

¹ The members of ISTC come from Barbados, Belize, the Dominican Republic, Eswatini, Fiji, Guyana, Jamaica, Malawi, Mauritius, Mozambique, Panama, the Philippines, and Zimbabwe. Together, the members of ISTC represent approximately one-half of the TRQ.

² Moreover, TRQ shortfall reallocation prior to the issuance of the March WASDE report does not affect Mexico's access under the AD/CVD Suspension Agreements, nor is any emergency determination required under the Farm Bill.
